Magnesium – co-factor of more than 300 enzymes

Magnesium is involved in almost all processes in the cell. This mineral is particularly important for muscle function, the nerves and the nervous system, the maintenance of normal teeth and bones as well as for the electrolyte balance within the body. In the case of an increased requirement, due to stress or sports for example, a magnesium preparation can support the intake of magnesium in a targeted manner. Attention should be paid to magnesium with the regular intake of drugs (e.g. protection for the stomach (proton pump inhibitors)).
